



## **GODSPEED BRAKES MAESTEG DMC CLUB CHAMPIONSHIP RULES 2024**

**1.** MDMC will run a two tier Club Championship in 2024.

The categories will be:

A – Stage Rally, Road Rally, Targa Rally and Navigational Scatter.

B – Hillclimb, Autotest, and Tour\* (\*on which results are produced).

There will be no restriction on the amount of events contested. Events may also take place outside the UK and must be sanctioned by the countries governing body. For example, UK events must be Motorsport UK sanctioned.

### **2. CLAIMING OF POINTS.**

**POINTS FOR EACH QUARTER OF THE YEAR MUST BE SUBMITTED BY THE FOLLOWING DATES AND PREFERABLY ON CLUB NIGHTS:**

**MAY 21st 2024. JULY 25<sup>TH</sup>. OCTOBER 15<sup>TH</sup>. JANUARY 7<sup>TH</sup> 2025.**

PROOF THAT MDMC IS STATED ON ENTRY LISTS THAT HAVE PROVISION FOR CLUB NAMES, AND PROOF OF YOUR OVERALL AND CLASS RESULT MUST BE PRODUCED. IN AN EVENT THAT DOES NOT HAVE CLASSES, YOUR OVERALL SCORE WILL BE USED TO AWARD YOUR POINTS.

**Proof of results from Ewrc is not acceptable** as they often do not differentiate between driver and co-driver results.

It is not the responsibility of the co-ordinator to have to scrutinise and search for event entry lists and results. You need to provide them.

It is the member's responsibility to ensure these results have been received. If the Co-ordinator is not present at the Club then the results and entry list may be given to a Committee member. Points may only be claimed from the date a member joins the Club. You can also submit results by Whatsapp or via a Facebook message to the Co-ordinator, **not** to the Club Facebook page.

**3.** Contenders must request Maesteg and District Motor Club stickers for each side of the vehicle, and carry sponsors stickers if provided, unless it is forbidden by the event organisers. In the spirit of the Championship and the way in which the Club is run, reports that a member is not carrying stickers will not be acted upon.

**4.** The Club name must appear on Final Entry Lists where there is provision to do so. If an event organiser omits the Club name, the Championship Co-ordinator must be satisfied that every effort has been made to rectify this. For example, proof of correspondence from you to the Event Entry Secretary requesting that it is added. Stating an additional Club is acceptable.

**5.** Even if a competitor achieves for example, 3rd in class on an event, he/she will gain maximum points if there are no other Club members in 1st and 2nd place. Points will be 16 for the top contender in their class on each event, followed by 14, 12, 10, 8, 6, 5, 4, 3, and 2 for 10th or lower. If Classes are amalgamated on an event, the position that appears in the Final Results will stand. 1 point will be gained for a non-finish. For representing the Club out of mainland UK, a bonus 5 points will be awarded irrespective of whether a Member finishes the event or not.

**6.** Awards will be for positions as follows:

Category A

1st Driver,

1st Co-driver / Navigator-

Perpetual Award, Replica and £100 each.

2nd Driver – Award

2nd Co- driver / Navigator - Award

3rd Driver – Award

3rd Co-driver / Navigator – Award

Category B

1<sup>st</sup> Driver

Award and £100

1<sup>st</sup> Tour Co-driver\*

Award and £25. (Where results are provided).

As a courtesy to our sponsor, award winners must make every effort to attend the Presentation Night. If they are winners of a cash prize and cannot attend, it will be at the Committee's discretion whether they will forfeit their winnings. Additional prizes may be added at the discretion of the Committee. If Junior Awards are presented, the Winners will receive complimentary membership for 2025. The recipient must be under 22 years of age on January 1<sup>st</sup> 2024.

7. It is not necessary to register for the Club Championship.
8. Claiming of points in the Championship signifies acceptance of the rules.
9. It is intended that points will appear on the MDMC page of the Rally Challenge website and notification that they have been published with a link will appear on the Club Facebook page.
10. The Club Committee shall adjudicate on any disputes and their decision shall be final.
